Rental Contract

Renters responsibility while renting an ATV from Reds ATV Rentals / Reds Rentals and Repairs

1. The renter will accept full responsibility and cost to repair or replace the rented ATV in the case of fire, theft, or accident
2. Repairs will be done by Reds Rentals and Repairs and charged to the renter at a cost of \$80/hr.
3. The renter may purchase insurance to cover the use of rental units at the renters choice of insurance broker.
4. The ATV should not be driven abusively
5. ATV's must be returned as clean as when they were picked up. If not they will be charged a minimum \$30 fee at Reds Rentals discretion.
6. The renter agrees they absolutely will not use or consume alcohol or drugs while renting and riding the rented ATV.

Normal Use Of Rental ATV's

1. Damage occurring to ATV is the full responsibility of the renter. Repairs will be charged to the renter @ \$80/hr plus the cost of parts, shipping of parts and any other expense incurred for the full repair of the ATV.
2. Rental units will be delivered with full tanks of fuel and must be returned with full tanks of fuel.
3. On return of unit the leaser will do a full inspection of / for damage. The renter may be present for the inspection.
4. A visa or mastercard is required for damage coverage on the rental of each ATV rented, and a \$500 cash deposit may be required at pick up at the discretion of Reds ATV Rentals / Reds Rentals and Repairs.
5. If an ATV is returned and there is evidence of water being in the air box and or the engine crankcase the renters will be immediately charged \$500 and will be charged the full cost of the repair once repairs have been made.
6. ATV's must not be driven abusively.
